

PARTICIPATION FORM AND RELEASE OF ASSUMPTION OF RISK FOR DOMESTIC RETREATS

Please carefully read the below terms and fill out the information requested.

Cancellations from Guests

Due to our commitment to accommodation providers, instructors, tour operators etc, we cannot make any exceptions to the below-mentioned cancellation fees. We do not offer any credit for arriving late or departing early, missing activities or not using any part of the scheduled program.

Cancellations received:

- Prior to 60+ days from the start of the booked retreat date: You will forfeit the non-refundable deposit. If payment in full has already been made, you may transfer 100% of this payment (less the deposit) to a future retreat, to be used within 18 months from date of booking, or request a full refund (less the deposit).
- Between 45-60 days prior to the start date of your booked retreat: You will forfeit the non-refundable deposit. You may transfer 100% of the retreat fees (less the deposit) to a future retreat, to be used within 18 months from date of booking, or request a refund of 75% of the retreat fees (less the deposit).
- Between 0 and 45 days prior to the start date of your booked retreat: No refund or transfer is allowed and you will forfeit 100% of your retreat fees paid.

Every retreat participant must provide Retreat Here with full details of their travel insurance (or else agree to bear the costs of injury or illness) at the time of final payment, as well as a signed copy of the participation form and release waiver. Failure to provide these documents may result in cancellation of your booking and forfeiting the non-refundable deposit.

Our responsibility to you:

As the retreat operator, we make arrangements with other parties to provide you with some of the services on your retreat. These parties are independent suppliers over whom we have no direct control. Retreat Here nor One Life Yoga holds no responsibility for independent contractors (or weather conditions) changing services on the retreat.

Retreat Here and One Life Yoga are not responsible for any claims, losses, damages, costs or expenses arising out of injury, accident or death, damage, loss or delay of baggage or other

property; or delay, inconvenience, loss of enjoyment, or frustration, whether physical or mental resulting from: (1) the act or omission of any party including Retreat Here or its employees; (2) mechanical breakdown, government actions, weather or other factors beyond our control; (3) your failure to read information provided and follow instructions including, but not limited to, obtaining sufficient travel protection & health insurance and providing correct & complete personal, health and travel information; (4) your cancellation or change for any reason in travel services offered; and (5) your medical or health problems or physical disabilities.

We maintain a standard of never cancelling a retreat which has guests booked on it, but in the event of a cancellation made by us, Retreat Here's liability will be to refund all monies paid on unused Retreat Here services only. Retreat Here is not responsible for any fees caused by such cancellation paid to airlines and any other agreements made by guests with outside operators.

Participants must notify Retreat Here of any dietary restrictions and allergies at the time of booking. Please note: as we work with several retreat venues, hotels and resorts, we might not be able to cater to all food restrictions. Liability waiver and Assumption of Risk

In consideration of the services of Retreat Here, their agents, owners, officers, volunteers, participants, employees, service suppliers and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "Retreat Here"), I hereby agree to release, indemnify, and discharge Retreat Here, on behalf of myself, my children, my parents, my heirs, executors, administrators, assignees, personal representatives and estate as follows:

A. I acknowledge that yoga and traveling entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. My participation in all retreat activities is purely voluntary, and so expressly agree to assume the risk of injury or damage while participating in all activities during my retreat and are not grounds for a refund or discount. Furthermore, Retreat Here's guides and instructors have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather, the elements, or the terrain. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

B. I acknowledge I wish to participate voluntarily in the DIY skincare workshop by Reality is With Bethany: the making and use of skincare products using soaps, extracts, essential oils, and carrier oils. Products included but not limited to: cleanser, toner, serum. I hereby waive, release and discharge Reality is With Bethany and Retreat Here for all liability for or by reason of any damage, loss or injury of myself and I have notified Retreat Here of any skin allergies or sensitivities.

C. Accordingly, I agree that I am voluntarily participating in any and all activities, risks, and use of the accommodations, and hereby assumes all risk of injury, illness, damage or loss to person and property that might result, including, without limitation, any loss of personal property. I expressly agree and promise to accept and assume all of the risks existing in the practice of yoga with knowledge that the risks of participating in this activity include, but are not limited to, sprains, strains, broken bones, paralysis, even death; exhaustion.

D. I certify that I have adequate travel protection insurance should I need to cancel or change my travel plans & health insurance to cover any injury or damage I may cause or suffer while participating on any of the retreat activities, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

E. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Retreat Here, its officers, employees and suppliers against all claims of losses, causes of action, damages or expenses of claim and against any costs including legal fees that may be incurred

as a result of any such claims losses, damages or expenses whether valid or not, including any such claims which alleged negligent acts or omissions of Retreat Here.

F. Should Retreat Here or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs, and I declare to not take any legal action in any country.

G. Guests are responsible for any damage that may occur at the retreat venue during their stay and may be invoiced by the venue accordingly.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation on a retreat, I may be found by a court of law to have waived my right to maintain a lawsuit against Retreat Here on the basis of any claim from which I have released them herein. This is to certify that Retreat Here, its employees & suppliers are released from any responsibility for any loss, mishap, accident, injury or death that may occur during my participation a Retreat Here.

H. Guests are responsible to settle any incidentals (drinks, mini-bar or anything consumed at the venue that is not part of the retreat inclusions) prior to checking out of the venue.

I. By signing this waiver I acknowledge that retreat photographs and images which include me can be published by Retreat Here for the company's marketing purposes only.
